Annual Servicing

Servicing involves rigorous and comprehensive checking of all fire extinguisher components, by a competent, insured and authorised person, identifying faults, corrosion and partial or complete discharge Etc.

The purpose of annual fire extinguisher servicing is to protect your people and premises in the event of a fire breaking out. Servicing will involve assessing the suitability of existing equipment for your individual fire risks, including the current condition of your extinguishers, ensuring reliability.

Servicing

Servicing is required annually in-line with British Standards BS5306 Part 3, The Regulatory Reform (Fire Safety) Order 2005, your Fire Risk Assessment and insurers requirements.

Further Information

There is an obligation on the 'Responsible Person' within all organisations, through The Regulatory Reform (Fire Safety) Order 2005, Fire Safety Act 2022 and their Fire Risk Assessment to get all fire extinguishers serviced annually.

The minimum requirement for all businesses is servicing at least every 12 months and the next service interval should be planned and agreed in advance, to avoid potential issues and legal pitfalls, and of course to ensure compliance in the overall health and safety in the workplace.

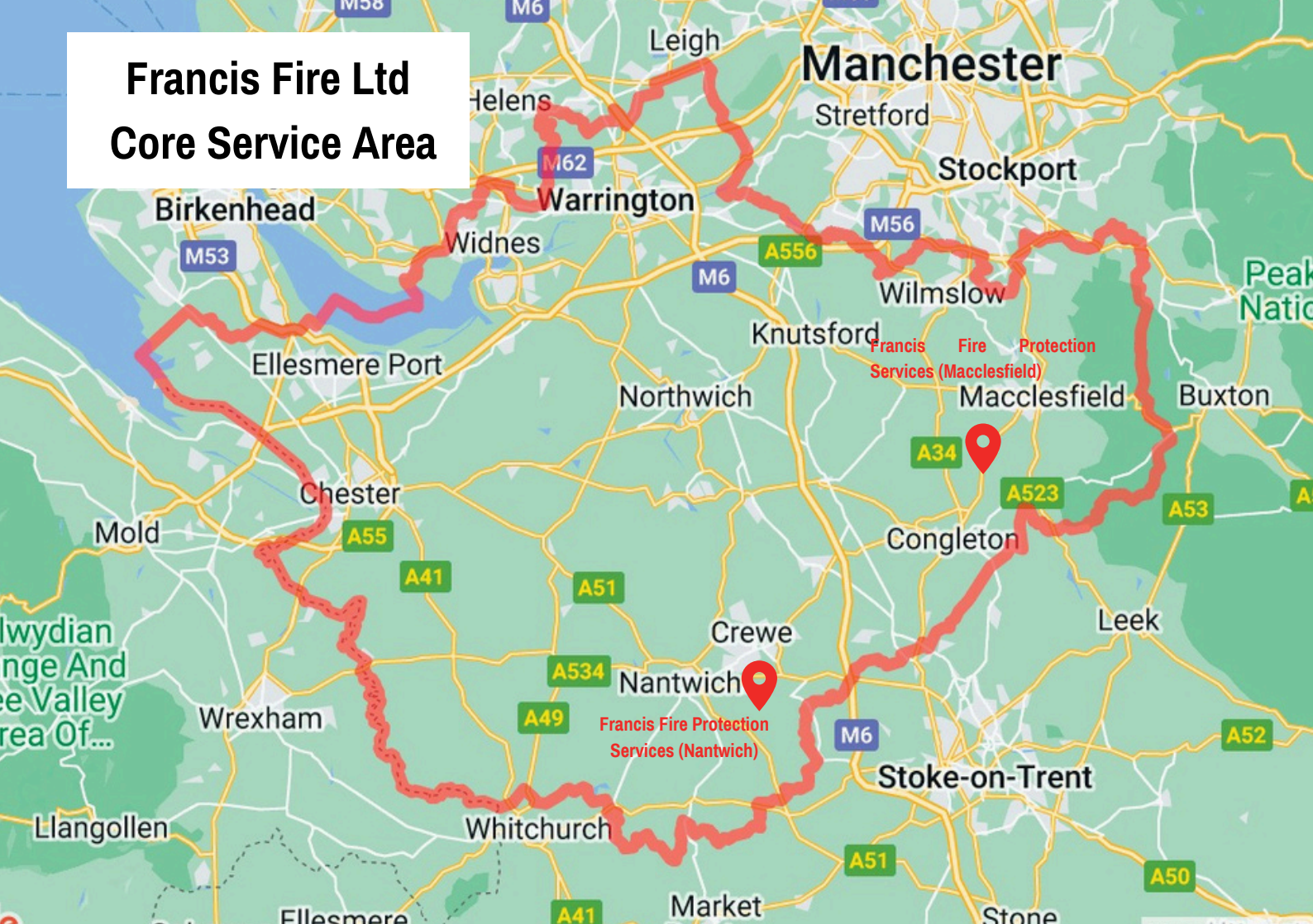
A fire risk assessment is a process involving the systematic evaluation of the factors that determine the hazard from fire, the likelihood that there will be a fire, and the consequences if one were to occur.

This involves a physical inspection of the building to determine the adequacy of the existing fire precautions and the need for any additional measures such as the quantity and types of fire extinguishers required.
